A step-by-step process to onboarding overseas talent

Eligibility criteria

To qualify for sponsorship, workers must be required to carry out a role that is determined by the Migration Advisory Committee (MAC) and is paid at least the minimum amount set out by them.

Minimum salary thresholds

The government's points-based system does allow for some workers to be paid less than the minimum salary threshold, for example, those roles on the shortage occupation list, graduates switching in-country, or candidates under the age of 26. UK Visas can provide instant advice on the eligibility of any job role, whether temporary or permanent, and can advise on the minimum salary thresholds that must be met.

Schedule of work

Our team can also provide you with an accurately costed schedule of work, saving you time and reducing additional admin.

Candidate selection

Once a candidate has been selected, our advisors will also liaise directly with them throughout the visa process, saving you time and ensuring that everyone keeps in-step throughout the process.

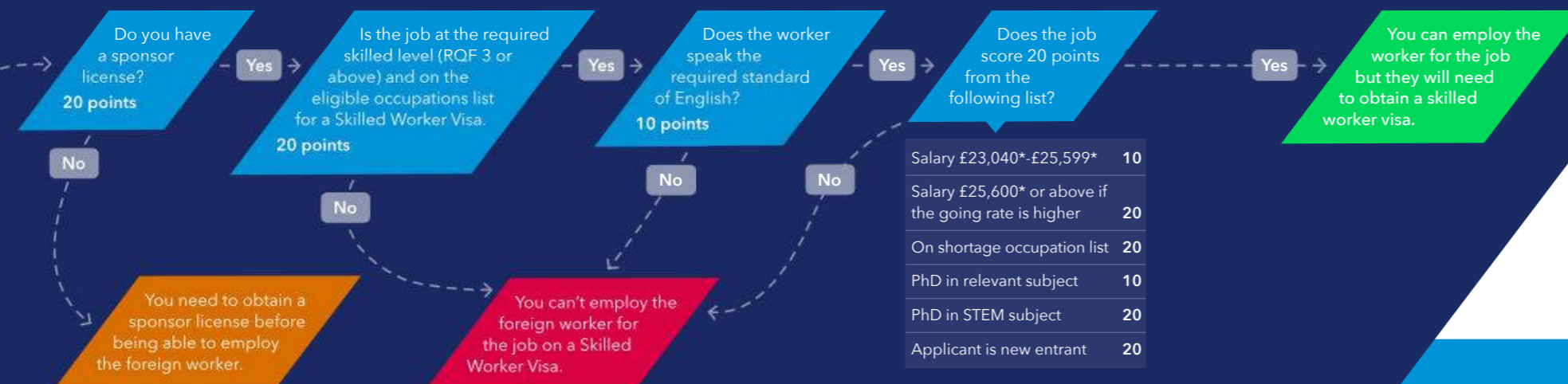

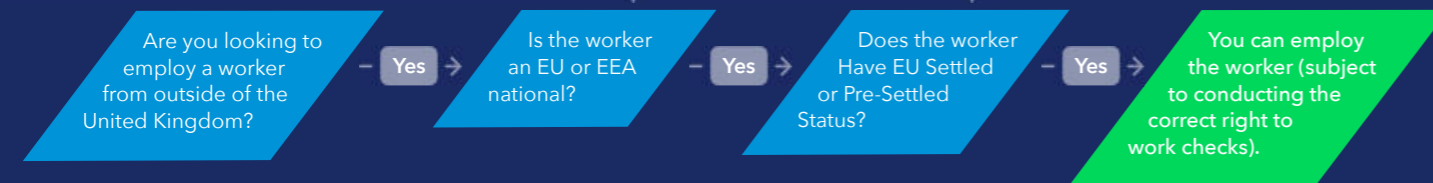
